### **Investment Objective**

The fund aims to generate superior returns by leveraging behavioral finance biases, including seasonality, myopia and trend. Registered in Switzerland, DUEP invests in equities and listed derivatives.

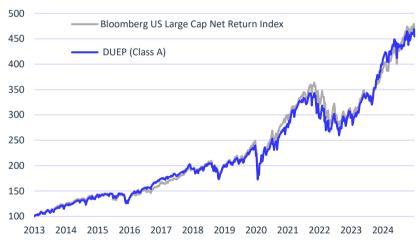
#### **Investment Manager**

Dominicé & Co – Asset Management is an investment management firm founded in 2003 in Switzerland. The company offers investment solutions in volatility, equities and real estate, as well as wealth management services.

### **Strategy Commentary**

After reaching an all-time high in the middle of the month, the S&P 500 declined, closing the month down 1.4%, reflecting investor apprehension over new trade tariffs and their economic implications. Ongoing concerns about mega-cap tech stocks also weighed on sentiment. Over the month, the communication services and consumer discretionary sectors struggled the most, while signs of sector rotation persisted within the index with consumer staples, energy, and real estate recording solid gains. The Fund outperformed its benchmark, with its basket of stocks performing well. In particular, the overweight position in Yum! Brands (+20.4%), the parent company of KFC, Taco Bell, and Pizza Hut, was a strong contributor. The company reported robust earnings and introduced new AI-powered technologies, which could lead to cost savings, faster service, and improved customer satisfaction. The derivatives overlay program had a neutral contribution, presenting below-average opportunities during the period. At the time of writing this report, uncertainties around the U.S. administration's policy agenda have pushed implied volatilities higher, as illustrated by the VIX hovering around 24. Heightened uncertainty and elevated volatility levels should create opportunities for the overlay in the medium term.

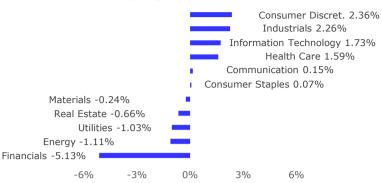
